**Tuition & Fees:** Tuition is broken up into 11 monthly installments (August-June) based on the number of hours your student dances per week. June is billed as a 2-week month (dress rehearsal and recital serve as student's last week of class). Tuition rates remain the same regardless of the number of classes there are per month (i.e. you are not charged more for 5-week months or charged less for 3-week months). Tuition and registration fees are non-refundable and not transferrable. Registration fee and first month's tuition is due at the time of registration. Your student will be registered for their class(es) and your card on file charged monthly tuition through June 2023 unless a cancellation form is submitted to Moves (*see Moves cancellation policy*). Missed classes may be made up in any comparable age/level class within 30 days of the absence. No refunds or credits will be issued for missed classes, class cancellations due to bad weather, expired makeups or any covid-related class cancellations. Recital participants must be registered no later than January 31, 2023 and remain registered through June 2023. Costume and related recital fees are billed separately and are non-refundable. Tuition is Auto-Billed to a credit card on file on the 26<sup>th</sup> of each month for the upcoming month of classes. (Ex. Your card on file will be processed on August 26<sup>th</sup> for the month of September).

**Late Payment Policy:** Should payment not be received by the 5<sup>th</sup> of the month, a \$20 late fee will be assessed. If tuition is not received by the 10<sup>th</sup> of the month your dancer will not be permitted to participate in their scheduled classes until payment has been received.

**Moves Cancellation Policy: 30-Day Notice Requirement for Cancellation.** Students wishing to end their commitment are required to fill out the 30-day written notice form, in person, to cancel enrollment. Billing and enrollment will cease 30 days from when the written notice is received. Moves considers your student enrolled in the class until we receive this written notice and will bill your account accordingly. We will only accept written notices on the Moves Cancellation form - email notification will NOT be accepted. If notice is given less than 30 days prior to cancellation, the customer is responsible for the full upcoming monthly tuition. Tuition will be pro-rated for the month based on the 30-day written notice of cancellation.

**Missed Classes/Make Up Lesson Policy:** Please notify the studio if your child will be absent from class. We gladly offer our students to make-up any missed class(es) within 30 days of your absence. You may make-up a missed class in any comparable age/level class on our schedule prior to our June recital. Please ask your teacher or desk staff for their class recommendation. No refunds or credits will be issued for missed classes, class cancellations due to bad weather, expired makeup classes or covid-related cancellations.

**Waiver & Photo Release:** In attending Moves Dance Studio/Program taking dance or exercise classes and otherwise using the facilities and equipment therein, I do so at my own risk. Moves shall not be liable for any damages arising from personal injuries incurred by me in, on or about the premises of the Moves Dance Studio/Program relative to my attendance at the dance studio, taking dance or exercise classes or otherwise using the facilities and equipment therein.
